- Click on row 1 to select Top or Header Row

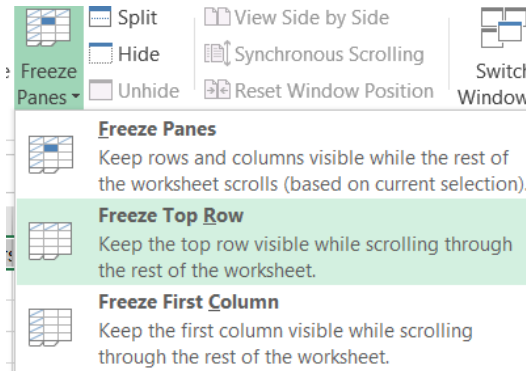
