NETZRO SBC: Attachment to Annual Benefit Report -- 2019

Stated Mission: *To create commercial products from existing food waste rather than from new resources, in order to preserve the natural environment for the benefit of current and future generations.*

The ways in which the corporation pursued and created the specific public benefit stated in its articles: NETZRO pursued its mission by conducting extensive testing, then designing and building equipment to process various byproducts of food processing into upcycled food ingredients. Most of the corporation's work in 2019 was devoted to working with spent grain left over from alcohol distilling and beer brewing.

The extent to which that specific public benefit purpose was pursued and created: NETZRO entered into a formal working relationship with Tattersall Distilling of Minneapolis to locate NETZRO equipment in the distillery for continuous processing of spent grain. NETZRO also worked on enhanced communications to educate about and promote the use of upcycled ingredients.

Any circumstances that hindered efforts to pursue or create the specific public benefit: NETZRO's need for capital (in advance of having a revenue stream) has been a challenge and a factor that has slowed the company's progress.
