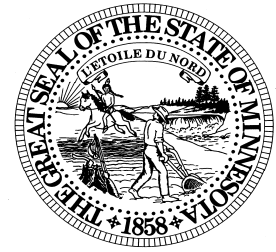

Articles of Conversion

Minnesota Statutes, Chapter 317A



Read the instructions before completing this form.

Filing Fee: \$55 for expedited service in-person, \$35 if submitted by mail

- Nonprofit Corporation (Domestic) governed under Chapter 317A converting to a Nonprofit Corporation (Foreign).

Conversion is only allowed if the statute governing the entity into which the domestic nonprofit corporation is being converted also prohibits pecuniary gain and the payment of dividends, as required by section 317A.681, subd.2.

2. List the Home Jurisdiction of Organization before the conversion. (Required)
3. List the name that will be filed for the organization immediately after the conversion. (Required)
4. List the Home Jurisdiction of Organization after the conversion. (Required)
5. List the time the Conversion is effective under the governing statute of the Converted Organization.
6. List the terms and conditions of the proposed conversion, if any.
7. Check the appropriate box whether the notice to the Attorney General has been waived or is not applicable. (Required)
8. If the converted organization will be a foreign organization and is not authorized to transact business in this state, list the street address of an office that the secretary of state may use for the purposes of section 317A.689, subdivision 3.
9. Must be signed on behalf of the converting company or by an Authorized Agent (The signing party must indicate on the document that they are acting as the agent of the person(s) whose signature would be required and that they have been authorized to sign on behalf of that person(s).) (Required)
