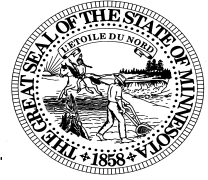

This Data Request is a means for requesting a set of records provided for bulk orders.

A Business Bulk Data Implementation Guide will be provided with your bulk order; however, if you would like to review the implementation guide prior to placing your order, please go to www.sos.state.mn.us. From the Business & Liens web page scroll to the section for Business & Liens Data. The Business Bulk Data Implementation Guide can be found on the Business Data Available web page.

Business bulk data will consist of these main record types: master data, filing data, and filing party and address data. The same file and record formats are used for all bulk orders created monthly.

The data is provided as a comma separated value (CSV) file. The file is delivered as a compressed (zip) file.

Data is purchased in bulk as a one-time set of records.

A signed license agreement will be needed prior to processing your order. The Bulk Business Data File is created at the beginning of each month. The name of the data file contains the date the file was created.
